Truck and trailer parking will be available.*

**Requirements:** Your booth must be neat, attractive and well maintained. Signage with visible and clear pricing is required. You are responsible for setting up, maintaining and removing your own booth and merchandise. Upon departure, your vending area must be cleared of **ALL** trash.

**Equipment:** Vendors must supply their own setup equipment. Tables, chairs, etc. will not be supplied. Electrical hook up is not available.

**Vendor products:** Automobilia, vehicle related, family oriented items are permitted to be sold. Illegal or illicit items are not permitted.  
Food vendors need not apply. If you carry a specialty food item, please contact us for approval.

**Weather:** This is a rain or shine event; be prepared for any type of weather. Tents, canopies and pop-ups must be secured to withstand wind, rain and other inclement weather. Stakes are not permitted on pavement.

## RELEASE AND WAIVER OF LIABILITY AGREEMENT
